2. Types of Data collected

The Personal Data may be given voluntarily by the User or automatically collected during the use of this Website. If not otherwise specified, this Website or the providers of third-party services used by this Website may use Cookies – or other tracking tools - to identify the User and save his/her preferences for purposes strictly connected to the supply of the service requested by the User.

If the User does not provide some of his/her Personal Data, this may cause the impossibility for this Website to supply its services.

The User takes responsibility of the Personal Data of third parties published or shared through this Website and ensures to have the right to communicate or disclose them, discharging the Data controller from any liability towards third parties.

3. Processing method

The Data controller processes the Personal Data of Users adopting the appropriate safety measures to prevent unauthorised access, disclosure, change or deletion of Personal Data.

The processing is carried out by using computer and /or telematic tools, with organisational methods and logic strictly related to the purposes mentioned. 6. User's exercise of the rights
